



Innovative Industrial Properties Declares Third Quarter 2019 Dividends

Common Stock Dividend Increased 30% from Prior Quarter and 123% from Q3 2018

SAN DIEGO--(BUSINESS WIRE)-- Innovative Industrial Properties, Inc. (IIP), the first and only real estate company on the New York Stock Exchange (NYSE: IIPR) focused on the regulated U.S. cannabis industry, announced today that its board of directors has declared a third quarter 2019 dividend of \$0.78 per share of common stock, representing a 30% increase over IIP's second quarter 2019 dividend of \$0.60 per share of common stock, and an approximately 123% increase over IIP's third quarter 2018 dividend of \$0.35 per share of common stock. The dividend is equivalent to an annualized dividend of \$3.12 per common share, and is the fifth dividend increase since the Company completed its initial public offering in December 2016.

Additionally, IIP announced today that its board of directors has declared a regular quarterly dividend of \$0.5625 per share of IIP's 9.00% Series A Cumulative Redeemable Preferred Stock.

The dividends are payable on October 15, 2019 to stockholders of record at the close of business on September 30, 2019.
